MOBILE DEPOSIT

By the time you receive this newsletter, the mobile deposit function will be operational in the mobile app. Members will have the capability to take a picture of their check, both front and back, and deposit the check into their account! FYI... you need to endorse your name as it appears on the front of the check **AND** write "mobile deposit" underneath your endorsement. You will need our Touch Banking app for this function. Please follow the directions on the mobile app to ensure no deposit delays.

BILL PAY

You will be able to pay your bills with this feature, transfer monies from your credit union to another financial institution. You **MUST** have a checking account with UFFCU.

DEBIT CARDS

If you have a checking account and have a debit card, please take the time to download the debit card app. **Card Valet.** The app will alert you when your card has been used, you are able to check your checking balance, turn the card on or off. There are many features that you are able to utilize.

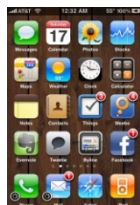
SUBJECT TO CHANGE DUE TO COVID

MOBILE APP

Account Access:



We are pleased to announce we have launched a mobile app for you to download on your smartphone, Touch Banking! You must be enrolled on NetBranch online banking prior to downloading the app. Call the Credit Union and the office staff will gladly assist you.

ONLINE & MOBILE BANKING – Members have access to their accounts via online (netbranch) and the Touch Banking mobile app. If you have not already done so, it's a good time to register for online banking and our mobile app. Call the Credit Union and the office staff will gladly assist you.

Communication:

UPDATE CONTACT INFORMATION – Make sure your contact information is current – especially your mailing address, primary email and the best phone number we can use to reach you. You can update this information via netbranch, in person or in writing.

CAUTION

Remember that UFFCU will never call a member to ask for confidential information such as password, PIN, SSN or security code on the back of their card.

If you are suspicious of the caller, hang up and call our number directly.

SHARED BRANCHING

MORE LOCATIONS FOR YOUR CONVENIENCE



Union Fidelity Federal Credit Union has joined the Share Branching Network, which means you can complete transactions on your account at more than 2,100 credit unions and service centers nationwide. Visit any of the participating credit union branches or service centers to take care of a number of financial transactions, such as withdrawals, deposits and loan payments.

YOU WILL NOT BE ABLE TO CLOSE YOUR ACCOUNT AT A SHARED BRANCHING CENTER, NO EXCEPTIONS ALLOWED. You must have a valid photo ID (Driver's License, Passport, Military ID), Credit Union Name and your Account Number, (CU Service Centers do not have the ability to look up your account number by your social security number). You will incur a small transaction fee. Find a location near you by accessing their website at www.msc.coop or call 1-800-919-2872

FREE CHECKING



Every member is eligible to open a checking account with the Credit Union. No credit check required!! The minimum to open an account is \$200! A small dividend is paid if you maintain an average daily balance of \$500. Your account will incur a \$5 service fee per month, if your balance falls below \$500 any one day during the month. Call the Credit Union for more information

INACTIVITY ACCOUNT FEE

Accounts without any activity within the year will be assessed a \$15 yearly fee on the last day of each year. To avoid a yearly fee, simply make a small deposit and/or withdrawal anytime during the year.

UPDATE YOUR SIGNATURE CARD

HAVE YOU CHECKED THE JOINT OWNER AND OR BENEFICIARY ON YOUR ACCOUNT LATELY?

It is extremely imperative that your signature card be completed correctly with a current joint owner and/or beneficiary. If you need to make any changes because of marriage, divorce, death, etc., call or stop by the Credit Union to update your card.

NEW VEHICLE LOAN
